The Importance of Postgraduate Study...

For society:

- Underpinning HE Sector
- Generating new knowledge vital to research base
- Social and cultural benefits.

For the economy:

- CIHE: 7 out of 10 employers sought out Masters students
- Produces a highly-skilled workforce.
- Economic/business growth and global standing.
- Generating income/providing support for UK HE.

The Importance of Postgraduate study

For the individual:

- Increased employment prospects and earning potential
 - 6 month employment record 71% Masters, 83% PhDs
 - 1 in 8 PG employed where no degree required found a related job, 1 in 3 UG
 - Less affected by economic downturn
 - Masters: Women earn 55% more than base, men earn 29% more, PhDs: women 60%, men 31%
 - 24% Postgraduate premium
 - Required for certain professions
- As a conversion course
- > Better equipped for academic research






Where is the competition coming from?

Relative attractiveness of country destination favoured by international PGR students






In 2009/10, international students:

New Zealand

Since 2006, new international PhD students have been accorded domestic status for the purpose of tuition fees in New Zealand.

In addition:

- Dependant children of international PhD students are classified as domestic students in New Zealand state schools.
- International students who graduate from a course recognised under the Skilled Migrant Category are eligible for a six month work permit.
- Once graduates have gained work this way, they can apply for a poststudy two year work permit or residency under the Skilled Migrant Category.
- Partners of international postgraduate students can apply for a work permit valid for the duration of the student's course of study

We must maintain:

- > A world leading research base.
- > A world leading student experience
- > A broad discipline base.
- > Recognition of the widespread impact of PG study.
- Support for internationalisation of PG study.
- > Links between Postgraduate provision and employers/users of research.

Further factors:

The need for incentives/methods to encourage the uptake of postgraduate study:


- Encouraging industry sponsorship
- Repayment holidays
- Further promotion of UK postgraduate education
 - A more comprehensive approach to widening participation.
 - A sustainable long-term approach to loan provision.
 - Expansion of alternative modes of study
