




Freedom and Flexibility – the rationale


An Innovation Code which enables colleges and providers to develop new programmes which meet the needs of their communities

About shared responsibility with learners and employers

•Recommendation - A dynamic nucleus: Colleges at the heart of local communities (Nov 2011) - supporting providers in delivering responsive provision which meets locally assessed priority needs.

•Skills Funding Agency introducing the Code for the 2012/13 academic year, enabling colleges and training organisations to draw down funding whilst simultaneously developing the programme and qualifications.

•Qualifications designed in partnership with business, with a commitment to time limited funding, and expected to migrate onto the Qualifications and Credit Framework (QCF) through the process.

The Skills Funding Agency will reduce its administrative costs by 33% by 2015










Freedoms and Flexibilities: Less Regulation

Simplified FE and Skills System: Reducing regulations

- New, simplified and clarified regulatory framework for colleges putting colleges on similar footing to other charities.
- Repeals legislative requirements that impose unnecessary or inappropriate controls on colleges
- Transfers power to modify and replace a college's instrument and articles of government to the college
- Provides 'light touch' set of requirements in legislation for Instruments and Articles
- Transfers power to dissolve a college to the college itself, with responsibility to undertake consultation, and to transfer its property, rights, and liabilities
- Gives the 'in extremis' powers to intervene in the affairs of colleges to the Secretary of State





Freedoms and Flexibilities: Supporting local partnerships


A City Skills Fund to support effective working between colleges, providers and Cities

• Worth £4.5 m in total - available to eight core cities (Manchester, Liverpool, Leeds, Birmingham, Bristol, Nottingham, Newcastle and Sheffield) and London.

• Facilitates cooperation and partnership between LEPs, Cities, and colleges/providers.

• To develop shared understanding of key skills priorities and how they will be met.

• Cities can develop innovative approaches to establishing Apprenticeship hubs.



A confident sector that sets standards and safeguards its reputation

• £15m allocated to support sector efficiency and innovation through collaboration and shared services

 Innovation Pilots - projects expected to save £25m over two years

 Benchmarking pilots to assess colleges costs e.g. HR, IT

 Sector led National Improvement Partnership Board developing 'efficiency indicators'

• VAT exemption for shared services
