

Summary of framework proposals:


Report on the quality of provision by giving priority to the:

- outcomes for learners
- quality of teaching, learning and assessment
- effectiveness of leadership and management

Continue to judge the overall effectiveness, based on the above



Overall Effectiveness: the proposed framework





Summary of framework proposals:

We will cease:

- routine inspection of most outstanding providers unless their performance drops (subject to legislation)
- application of 'limiting grades'
- reporting separately on equality and diversity, but embed in three main aspects: learner outcomes; teaching, learning and assessment; and leadership and management
- grading ECM themes, partnership working, needs and interest, capacity to improve, governance, safeguarding, students support
- to report **fully** and separately on a sample of subject areas



Summary of framework proposals:

Increased focus on:

- direct observation of teaching, learning, skills development and assessment activities
- success and rates of progress of different groups of learners
- the extent to which the provision meets learners/local needs, ensures achievement for all and enables positive progression
- raising standards for learners by improving inspection practice
- capacity to improve, but within the context of leadership and management; a providers ability to raise standards of student learning and achievement
