



# Spending on Widening Access


1) National Scholarship Programme:








Higher education institutions' access agreement expenditure, excluding the National Scholarship Programme

- have disabilities
- obtain lower degree classifications




# A “perfect storm” ahead for postgraduate study?

“Fees for postgraduate courses are increasing, whilst a credit crisis, with banks less willing to offer career development loans, continues”

“future student cohorts will be less willing to incur further debt”
