

# Issues Facing Britain: Crime continues to not be main issue of concern


What do you see as the most/other important issues facing Britain today?

Figure 5.1 Perceptions<sup>1</sup> of changing crime levels, 1996 to 2010/11 BCS




# The Police are pretty well rated on many fronts; we generally trust them, are increasingly confident in them and can't bear the thought of losing front line officers

#### Trends in ratings of the local police





# Perceptions of the local police remain positive with specific increase in police understanding local concerns





Police treat young people the same as adults



# Increase in public being confident that police are catching criminals







### ASB now seen as less of a problem than five years ago

British Crime Survey (now the Crime Survey of England and Wales) shows that fewer people cite ASB as a problem than did five years ago

- 4. Need more police




# Role of the police and newly elected PCCs





How worried, if at all, would you be if the police stopped providing the full range of services we have discussed due to budget cuts?





### **ASB** will be critical focus









- Problems are more acute in deprived areas and amongst vulnerable people
- High levels of repeat calls to police
- Resonance across communities and within the press
- To what extent can Commissioners engage and tackle?






- The young and those from deprived communities have a different range of issues too;

### What do you think should be the most important crime priorities for a newlyelected Police and Crime Commissioner in your area?



### We want...

Greater clarity about accountability would be reassuring

"I don't think there is any accountability because they [Police Authorities] are anonymous. If you did have an elected official at least you would have an idea of who has to be accountable to the area that they are overseeing"

> "The role of the PCC will be to reflect the opinions of the people in the area they are serving and to prioritise what the local issues are for the police."





### Challenge is to engage and enthuse

- How do we promote engagement?
  - Convince them it is worthwhile
  - That PCC's will be working for the public (not a political party!)
  - That they are there for young people and the less well off they understand key needs of these groups
- How do we foster more public involvement in local policing?
  - Show accountability => how do the public interact with the PCC??
  - Public desire for more meetings with both police and those overseeing them
  - More information about local crime issues, priorities, initiatives



# Tailored engagement is key



Neighbourhood officers have been working hard over the past month to reduce the amount of anti social behaviour associated with street drinking. Seventeen people have had alcohol seized from them since the community asked us to tackle street drinking in the Burmantofts area last month. Regular patrols have been taking place targeting public areas such as the cemetery. Local businesses in Lincoln Green square have reported a drop in the number of people sat outside drinking alcohol.

Using powers granted under the Designated Public Place Order (DPPO) neighbourhood officers are able to request any person, in a public place, in the Burmantofts area to stop drinking and hand over or pour away any alcohol they are consuming. Failure to do so can lead to a fine or even arrest. We will continue to target local priorities in your area.

There is a roughly equal divide between those who think public services do listen to the public and those who do not. Riot affected areas are more likely to disagree though.





# ...and local control...

If neighbourhoods take more responsibility for addressing crime and anti-social behaviour (such as through reporting crime or monitoring community CCTV), they should be given more control over police resources



# Different public perception measures

- Public confidence in policing (and the wider CJS)
- Satisfaction with police contact (including victims and witnesses)
- Perceptions of ASB
- Fear of crime



- What can newly elected PCCs do to influence the perceptions and engagement of local communities?
  - Accurate data about crime published and disseminated
  - Work closely with the community, particularly engaging with groups where confidence is low (i.e. hard to reach, unemployed, younger age groups)
  - Active community engagement helps PCCs gain a comprehensive understanding of local crime problems and concerns so they can tailor responses appropriately to local circumstances.
