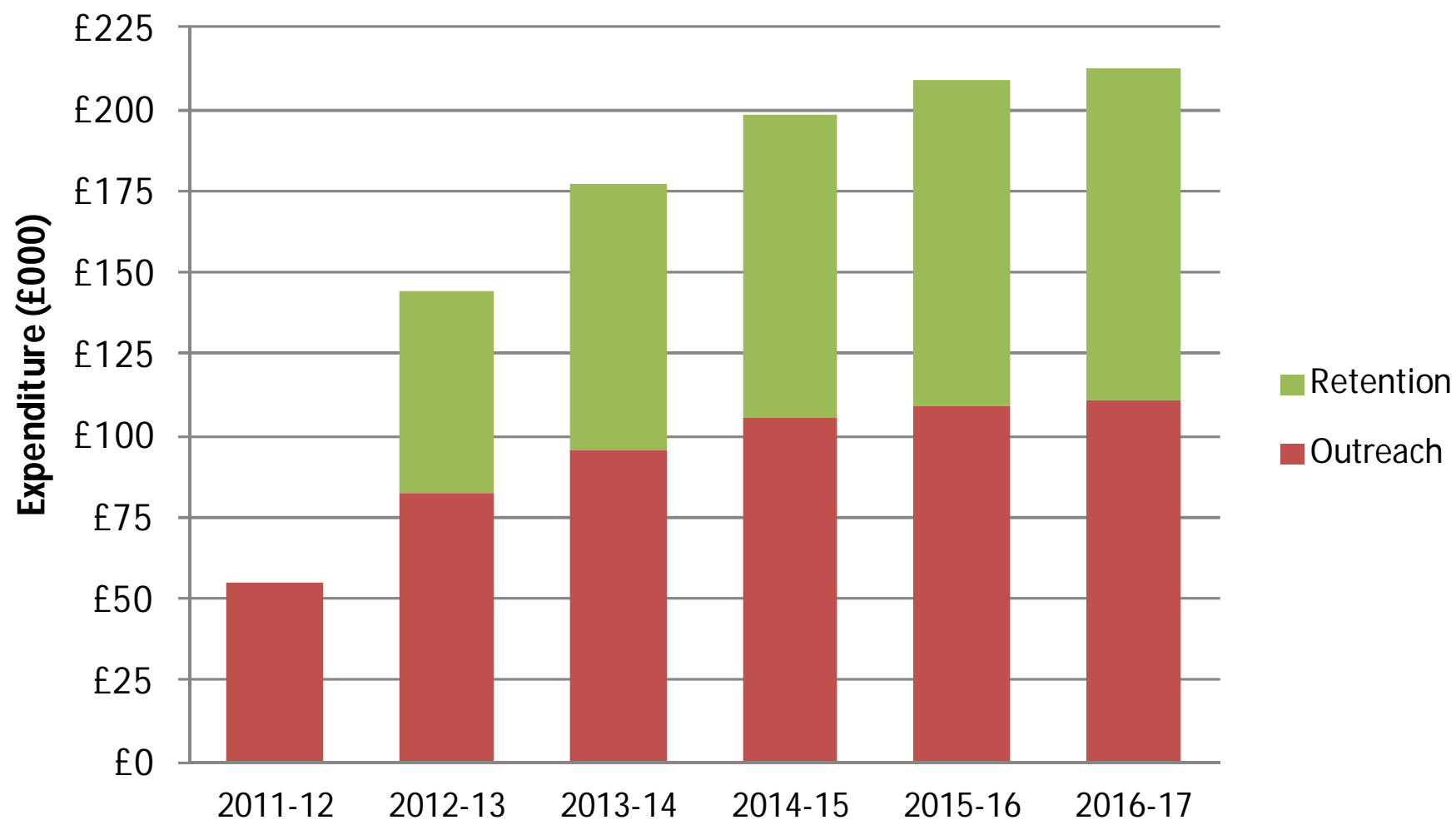

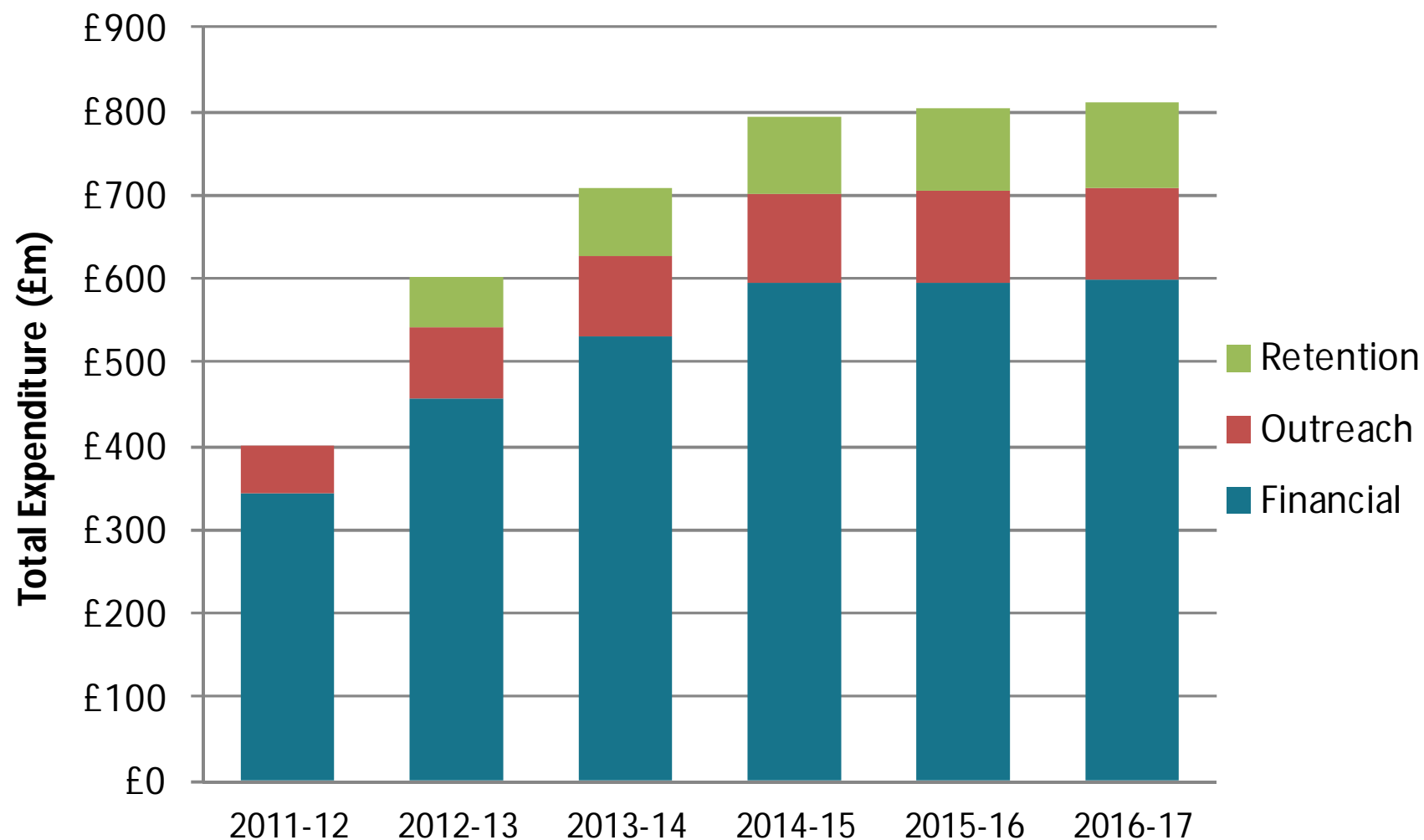

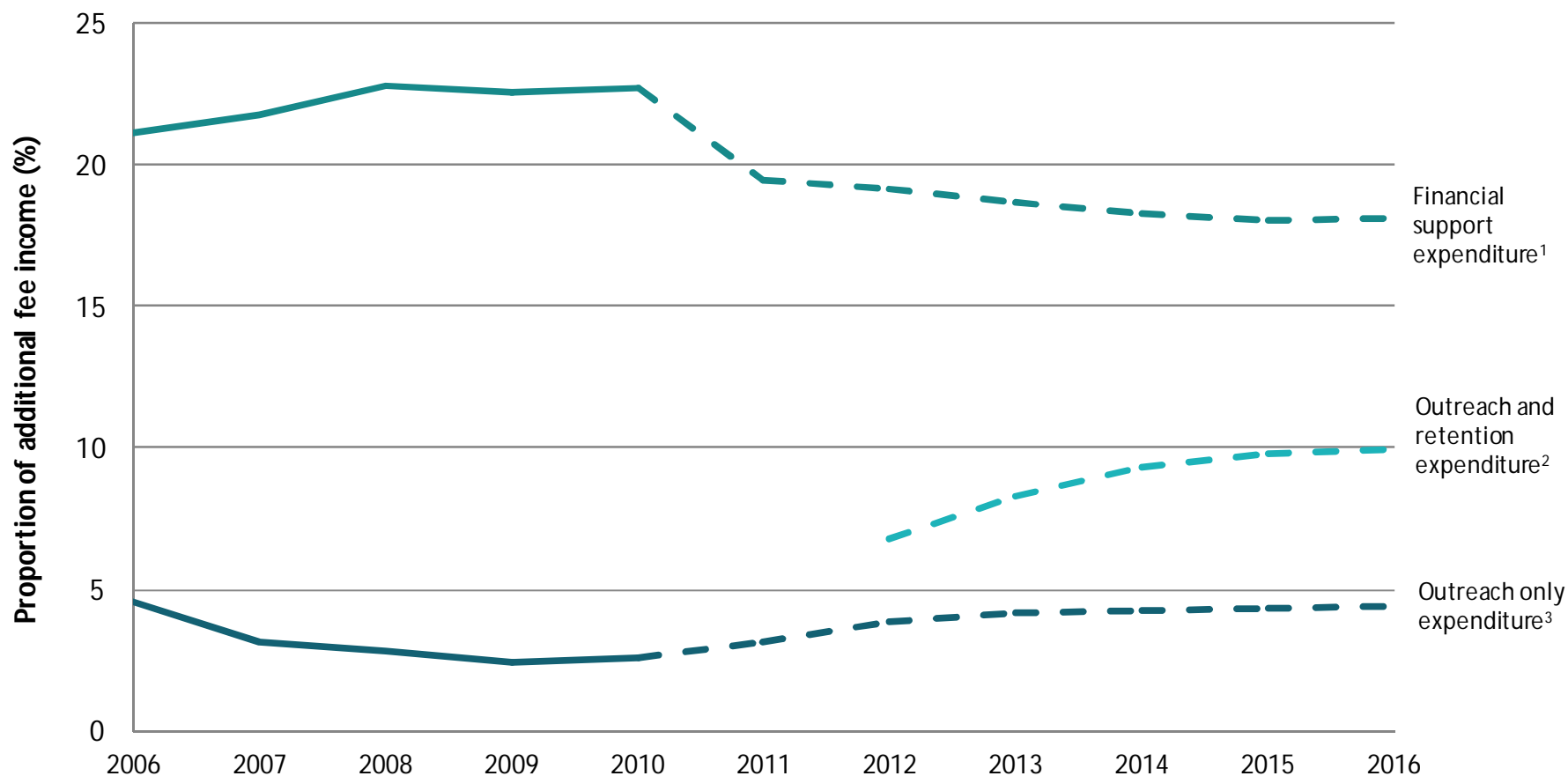
Estimated access agreement expenditure on outreach and retention 2011-12 to 2016-17: HEIs and FECs

3'Outreach only expenditure' includes access agreement spend committed to outreach activities

Evaluation

Increasingly important to access agreement approval and monitoring because:

- provides context
- demonstrates effort and illustrates performance of access measures
- (where successful) demonstrates progress underneath headline targets
- informs decisions on where to invest resources.





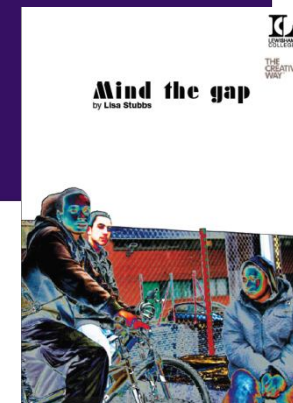
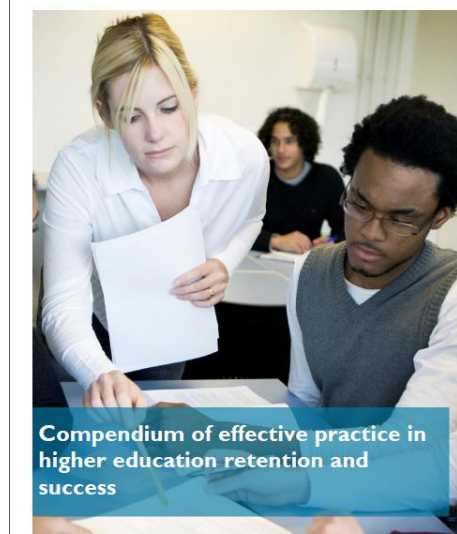
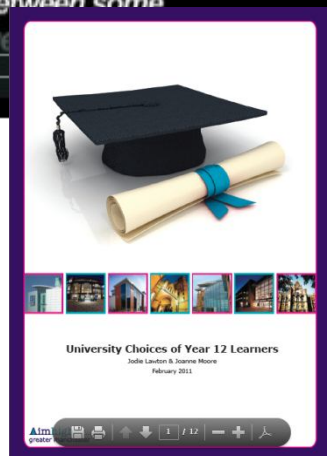
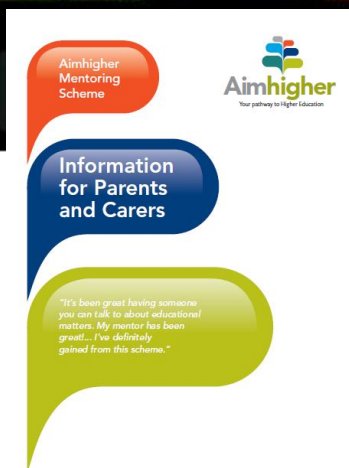
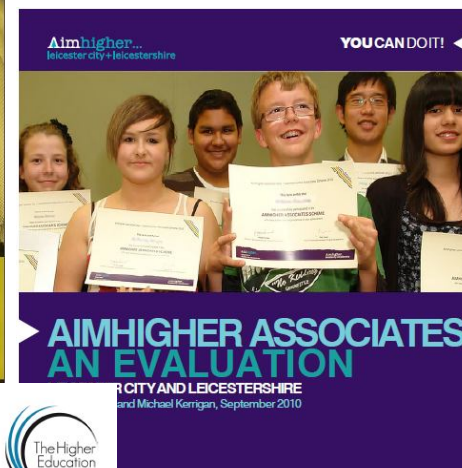
